

Honorable Governor Brewer,

Response to Mr. Charles Ryan Letter regarding Anant Kumar Tripati

I am writing to file a complaint that your appointed head of one of your Executive Agencies, Mr. Ryan, has submitted inaccurate responses on your behalf and used the responses as a vehicle to cover up illegal acts.

1. When writing for the governor or in any other instance it is imperative the response is factual and accurate.
2. Additionally, whenever family and friends have inquired about Anant Kumar Tripati and his failing health, most of the responses provided from ADOC and its affiliates have been deceitful.
3. Charles Ryan has been out right deceitful in his most recent reply of Dec 14, 2009 in his correspondence.

**In the recent months, Anant Tripati has collapsed on many occasions while in the hands of ADOC and the most recent being on January 9<sup>th</sup>, 2010. His blood pressure read 70/35mmHg which is dangerously low. The quick response of other prisoners and staffs helped to keep my husband from dying. I was told that he was also treated with 30 cups of salt and sugar water, a bowl of rice and fruits to revive him. This clearly shows that his major problem is his not being given his diet.**

I am so angry and outraged at the false responses which are coming from the highest level in the ADOC. In the event of Anant Kumar Tripati's death, you will not be able to claim ignorance because you have been relying on Charles Ryan exclusively. Charles Ryan has incentive to be deceitful, as the behavior of him and his employees are the subject of complaints. As the Governor, you have not ordered an independent investigation into these matters, which I do not understand.

At the State level, you as the Governor have the fully authority to resolve these matters promptly through an independent investigation into the stated issues. We - Tripati, his family, friends, and supporters - have given you all the opportunities to correct these issues.

We intent to raise the profile of these issues and specifically the condoning of the use of death by overriding doctor's orders as a tool of last resort for permanently covering up falsification of evidence by the State Agents.

Frankly, if you can not resolve this internal problem that is within your power, please inform me so I could address these unresolved matters to the United States Justice Department in DC for answers.

It should be noted, records from my husband's file were lost after 9/2/08 memos from Daryl Johnson ordered for this to be done. We believe Gene Greeley and Charles Ryan are working to

cause death of Anant Kumar Tripathi by overriding doctor's orders, in order to protect ADOC Central Office Staff and Arizona Attorney General's Office staff whose actions in falsifying evidence have been challenged by my husband.

Based on affirmed facts stated below, Charles Ryan is clearly disregarding inquires and is also concealing accurate information in his letter. Here are statements of facts:

- (1) ADOC staff destroyed original records including medical files from four (4) locations:
  - From Property Record Room--original property files was missing sometime after April 2008. Details are referenced in Aguilar memo of December 30th, 2008.
  - Medical Records--original medical records missing some time in July of 2008 and the Gene Greeley inmate letter response of January 22, 2009 confirmed this in writing.
  - From Institutional record area-- original memos missing after April 2008. These missing memos are documented in Daryl Johnson, Martinez, and other memos.
  - Now missing from Visitation Record Room is visitation records. Tripathi found out this on 12/11/2009 by Officers Clawson and Beverly and confirmed by Sgt Nettles on Dec 13, 2009 and also confirmed by email to Beverly CO III by Anna Jacob.

(2) No judge has found that any of the papers have been forged. It is very convenient for Charles Ryan to destroy the originals and now claim all copies of the document that were in those files are forged,

(3) On 12/19/08, Gene Greeley cancelled the doctors orders and issued a receipt of cancellation witnessed by Lieutenant Rodriguez,

(4) After 12/19 Gene Greeley directed Dr. Robert A. White to cancel all doctors orders and medical chart that had entries by Dr. White showing the dates when Dr. White changed the orders,

(5) To date, Tripathi has lost approximately 50 pounds as of June 2009,

Who are these appropriate personnel that Mr. Ryan refers to in his letter (paragraph 1, line 3)? It is important that their names be released to me so that they can all be equally held accountable and responsible in the event that my husband dies due to Mr. Gene Greeley not allowing him his prescribed diet. I will legally pursue each and every collaborator who has either passively or actively caused the decline of my husband's health and welfare.

Mr. Ryan's letter (paragraph 2) talks about BMI as a measurement of Tripathi's current health. His statement is completely misleading and fabricated.

For a 56 year old man to look as frail as a little boy is highly disheartening and abusive. To date all issues that have been raised regarding Anant's diet have been completely disregarded by ADOC. I have been a professional nurse for over 30 years and as a nurse educator am keenly aware of the serious consequences to the body when adequate calories are not consumed on a daily basis.

ADOC is blaming him for lack of cooperation which is a complete distortion of truth. There were a couple of instances when Mr. Tripathi was scheduled to be weighed yet was called to go to

visitor room because he had official visitors. Afterwards it was documented that he has not cooperated, when he simply could not be in two places at the same time. It is cowardly for ADOC to label him as uncooperative.

My husband does not see any reason why ADOC needs to regularly obtain blood samples from him. He has legitimate concerns about what these people are capable of doing with his blood sample. Do not forget, his whole medical record file has been lost and ADOC has had a history of fraudulently altering reconstructing 18 years of his health history as well as his prison file.

I really need answers from you as the Governor and Head of the State of Arizona why it is taking so long for truth and justice to prevail in my husband's case. Further, I ask that Anant be released to the Fijian Government or any Commonwealth country willing to take him to serve his sentence and at the same time he will be given proper healthcare and access to a fair and just hearing. I will take him back to Fiji.

In your response, please answer to paragraphs 3, 4, 5 of Mr. Ryan's letter, which is a complete fabrication of lies. ADOC is seeking an easy way out having to legitimately care for Mr. Tripati.

They have **LOST** his original files and have created new sets of documents to protect their own. Now, when it is convenient for them, they blame Mr. Tripati for their deliberately fabricated records. They must be held accountable for blaming forgery on Mr. Tripati. This is the same tactic they have used over the years to 'buy time' within the courts, while Mr. Tripati rots away in their custody.

I saw Anant Dec 5 and 6, 2009 and again on January 1, 2, and 3 of this year, he looked emaciated. It is truly a pity that all they can say is that he is not cooperating, that his weight is within normal limits and most falsely, that he has forged all these documents. How many more lies will ADOC manufacture and blame him for? As for being asked for notarized document from Anant, ADOC must provide any fee and the Notary of Public if this is a requirement since Tripati is in their custody.

After losing medical records, Gene Greeley overturned doctor's orders on 12/11/09. Prison staff lost property records. Other records on misconduct by the Attorney General and Central Office are lost. Other records on misconduct by the Attorney General and Central Office have been **conveniently 'lost'**.

Currently, the records from the fourth location have been lost. When Mr. Tripati went to get his medication, he was informed of his visitation file missing by Officers Clawson, COII and Beverly, CO III.

Gene Greeley destroyed medical records to cause Anant Tripati's death as a means of permanently ensuring Tripati does not challenge by use of false evidence by ADOC staff in Phoenix and the Attorney General's office. As stated by Daryl Johnson in his 9/2/ 2008 memo, Greeley shall be rewarded for his actions.

We, Tripati supporters urgently request an immediate investigation and action be taken. It is not possible that original records can be missing in for four locations without mal-intention and

collaboration. These records are being intentionally misplaced and destroyed to benefit those who have been attempting to suppress Mr. Tripati's legitimate justice in his case.
